Dear Grand Chief Polson and Chief Haymond:

Thank you for your correspondence of August 26, 2020, regarding nuclear project environmental assessments at Chalk River Ontario. I also appreciate your acknowledgement and potential interest in engaging with us on Canada's policies in the area of small modular reactors (SMRs) and the upcoming engagement process on radioactive waste.

The Government of Canada places the highest priority on public safety and security and environmental protection in all nuclear activities in Canada.

As indicated in Natural Resources Canada's (NRCan) letter of July 16, 2020, by the time the *Impact Assessment Act, 2019* was enacted, only those projects whose environmental assessment processes were already well underway would continue under the former regulatory process. In this instance, the Micro Modular Reactor Project, as well as Canadian Nuclear Laboratories' Near Surface Disposal Facility project at Chalk River Laboratories and its project to decommission the Nuclear Power Demonstration reactor at a nearby site, qualified and will continue to be assessed under the *Canadian Environmental Assessment Act, 2012*, which is being led by the Canadian Nuclear Safety Commission (CNSC).

NRCan understands the concerns you have raised about reconciliation and whether we are using the highest standards and best practices to engage and meaningfully consult.

As an agent of the Crown, the CNSC is committed to upholding the honour of the Crown and meeting its legal duty to consult and accommodate. The CNSC will actively reach out to Indigenous Peoples during an environmental assessment review process, consult with potentially impacted communities, and continue to engage and build relationships after a licence has been issued.



I would also like to reiterate NRCan's offer to hold broader-based, meaningful engagement and two-way dialogue with you on the topic of SMRs. As indicated in NRCan's letter of August 12, 2020, which you acknowledge, we hope to be able to provide information to you on the federal government's policy, plans, and priorities regarding SMR development in general and to provide an opportunity for us to listen, understand, and discuss your views. Our aim is to have an open discussion and build a relationship for engagement on SMRs moving forward.

As also noted in the letter of August 12, 2020, in the fall of 2020, the Government of Canada will launch an SMR Action Plan with provincial and territorial governments, Indigenous Peoples and communities, industry, and other partners. The Action Plan will build on the 2018 SMR Roadmap and outline the progress and ongoing efforts across Canada on SMRs. More importantly, the SMR Action Plan will emphasize our commitment to ongoing meaningful engagement with Indigenous Peoples, as well as the importance of partnerships and benefits sharing.

In the coming months, NRCan federal officials will also be working with stakeholders and Indigenous groups and will be talking to Canadians to ensure that Canada continues to have a strong policy framework and a clear path for the safe long-term management of all our nuclear waste. I am pleased that you plan on engaging in this process, which currently remains on track for commencing this fall.

NRCan has been informed that the CNSC will respond separately to the specific concerns you have raised and offer further opportunities for the Algonquin Anishinabeg Nation Tribal Council and the Kebaowek First Nation to be engaged in the decision-making for projects at Chalk River Laboratories.
